Introduction

Programme "Greening Economies in the European Union's Eastern Neighbourhood" (EaP GREEN) aims to support participating countries in their transition to a "green" economy and boost the "green" business. Participants of the programme are six countries of EU Eastern Neighborhood: Armenia, Azerbaijan, Belarus, Georgia, Moldova and Ukraine. The programme is funded by the European Commission (EC) and other donor-countries and is implemented jointly by the United Nations Economic Commission for Europe (UNECE), Organization for Economic Cooperation and Development (OECD), United Nations Environment Programme (UNEP), United Nations Industrial Development Organization (UNIDO).

One of the components of EaP GREEN programme is UNIDO demonstration project for realization of Resource Efficient and Cleaner Production (RECP) by creation of human and institutional capacities for RECP, demonstration, dissemination and replication of RECP in priority sectors (chemicals, food and construction materials) and transfer of RECP technologies.

One of the project's activity is holding of holding thematic forums that will cover topical issues of sustainable consumption and production:

- efficient energy consumption;
- reduction and safe waste disposal;
- supply sources and efficient water consumption;
- reduction and treatment of waste water;
- reduction and control of air emissions;
- selection and efficient use of materials.

Forum "Resource Efficient and Cleaner Production (RECP): Reduction and Control of Air Emissions" is the fifth of series of six thematic forums.

The aim of the Forum is to promote RECP among the wide range of stakeholders, in particular representatives of businesses, NGOs, science and education, state agencies etc, to discuss topic, share experience, ideas and constructive opinions on ways and methods of reducing harmful emissions and their control at small and medium enterprises of Ukraine.


A short survey will take place to assess the social opinion about the problems of industrial air emissions in Ukraine. The results will be analyzed and used to formulate the future tasks of RECP.
